Management Discussion of Fund Performance

November 13, 2018

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments during the period ended September 30, 2018, that have affected the ETF's performance and outlook. If the ETF was established during the period, "period" represents the period from inception to the end of the fiscal period. For information on the ETF's longer-term performance, as applicable, please refer to the *Past Performance* section of the report. In this report, "Mackenzie" refers to Mackenzie Financial Corporation, the manager of the ETF. In addition, net asset value ("NAV") refers to the value of the ETF as calculated for subscription and redemption purposes, on which the discussion of ETF performance is based.

Results of Operations

Investment Performance

During the period, the ETF returned -2.2% (after deducting fees and expenses). This compares with a return of 0.6% for the ETF's broad-based index, the MSCI EAFE (Net) Index, and a return of -1.4% for the ETF's narrow index, the TOBAM Maximum Diversification All World Developed ex North America Index. All index returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in the index without incurring fees, expenses and commissions, which are not reflected in the index returns.

The developed equity markets of Europe, Australasia and the Far East ("EAFE") benefited from increased economic activity over the period, as the global economy expanded despite continued trade and geopolitical uncertainty. However, currency depreciation relative to the Canadian dollar significantly reduced returns in Canadian dollar terms. The European Central Bank kept its policy rate steady, but confirmed that it will conclude its asset purchase program at the end of 2018.

The ETF's core investment philosophy is to seek enhanced diversification through a balanced exposure to all relevant risk factors in the non-North American developed country equity markets. As a result of this approach, the ETF may have less concentrated risk exposures than those of a market capitalization weighted index, such as the broad-based index.

The ETF underperformed the broad-based index primarily because of stock selection in Japan. Stock selection in the United Kingdom and Hong Kong also detracted from performance. On a sector basis, stock selection in health care and materials detracted. Conversely, stock selection in Germany and in the utilities sector contributed to performance. Given the ETF's mandate, the return of the narrow index is a more meaningful comparison.

The difference in performance between the ETF and the narrow index resulted primarily from management fees and other operating expenses. Withholding taxes paid on income also affected performance, as did the

ETF's sampling methodology, which replicates the performance of the narrow index by holding a representative subset of the securities included in the narrow index.

Over the period, changes were made to the ETF's holdings to reflect changes in the composition of the narrow index.

Net Assets

The ETF's NAV increased by 19.9% to \$102.0 million at September 30, 2018, from \$85.1 million at March 31, 2018. This change was composed primarily of \$2.4 million in net losses (after including dividend and interest income) from investment performance, after deducting fees and expenses, \$20.7 million in net sales, and \$1.4 million in cash distributions.

As a result of these investments, the ETF is subject to large transaction risk as discussed in the Prospectus. Mackenzie manages this risk to reduce the possibility of any adverse effect on the ETF or on its investors.

Recent Developments

Because the ETF is an index fund, neither market expectations nor recent developments affect the composition of the portfolio.

Related Party Transactions

The following arrangements result in fees paid by the ETF to Mackenzie or to companies affiliated with the ETF.

Management Fees

The annualized management expense ratio ("MER") for the ETF of 0.67% during the period ended September 30, 2018, was slightly lower than the MER of 0.68% for the year ended March 31, 2018. The ETF paid management fees to Mackenzie at the annual rate of 0.60% in the period. On October 10, 2018, the management fee paid by the ETF to Mackenzie decreased to an annual rate of 0.50% .

The management fee for the ETF is calculated and accrued daily as a percentage of its NAV. The ETF's management fees were used by Mackenzie to pay for the costs of managing the investment portfolio of the ETF, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio and providing other services, licensing the index, and to pay for all costs and expenses (other than certain specified fund costs as more fully described in the Prospectus) required to operate the ETF.


Other Related Party Transactions

Mackenzie is wholly owned by IGM Financial Inc. ("IGM"). IGM is a subsidiary of Power Financial Corp., which in turn is a subsidiary of Power Corp. of Canada. Companies related to Power Financial Corp. are therefore considered affiliates of Mackenzie. At September 30, 2018, the ETF held the following investment(s) in companies affiliated with Mackenzie: \$0.1 million invested in securities issued by SGS SA, \$0.2 million invested in securities issued by Umicore SA and \$0.1 million invested in securities issued by Pernod Ricard SA. The investment(s) represented 0.4% of the ETF's NAV. In making the investment(s), Mackenzie relied on the approval of the Mackenzie Funds' Independent Review Committee. The Independent Review Committee issued the approval on the basis that the investment(s) would be made in compliance with Mackenzie's policies. Mackenzie's policies are designed to ensure that any related party transaction (i) is made free from any influence by an entity related to Mackenzie and without taking into account any considerations relevant to an entity related to Mackenzie; (ii) represents the business judgment of Mackenzie, uninfluenced by considerations other than the best interests of the ETF; and (iii) achieves a fair and reasonable result for the ETF.

Investment funds managed by Mackenzie invest in the ETF in accordance with the investment objectives of those funds. At September 30, 2018, funds managed by Mackenzie owned 59.6% of the ETF's NAV. All related party transactions are based on the current market price.

Past Performance

If the ETF was established in the period, the management expense ratio is annualized from the date of inception. Mackenzie may waive or absorb operating expenses at its discretion and stop waiving or absorbing such expenses at any time without notice.

(3) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period. Mackenzie may reimburse the ETF for certain brokerage commissions and other transaction costs (including those payable to the custodian or its agents). Mackenzie may make these reimbursements at its discretion and stop these reimbursements at any time without notice.

(4) The ETF's portfolio turnover rate indicates how actively the ETF's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the ETF buying and selling all of the securities in its portfolio once in the course of the period. The higher an ETF's portfolio turnover rate in a period, the greater the trading costs payable by the ETF in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of an ETF. The portfolio turnover rate is not provided when the ETF is less than one year old.

(5) Closing market price, or the midpoint of the bid and ask prices in the absence of a closing market price, on the last trading day of the period as reported on the Toronto Stock Exchange.
