Tyler Hewlett, Senior Vice-President and Portfolio Manager, will be promoted to Senior Vice-President, Portfolio Manager and Co-Lead, Bluewater and will assume Mr. Arpin's responsibilities. The rest of the Team will continue to manage the Funds. There will be no changes to the Team's investment process.
