Management Discussion of Fund Performance

June 3, 2022

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the Fund's performance and outlook in the year ended March 31, 2022 (the "period"). If the Fund was established during the period, "period" represents the period since inception.

In this report, "Mackenzie" and "the Manager" refer to Mackenzie Financial Corporation, the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

Investment Objective and Strategies

Effective June 4, 2021, the Fund's investment objective was changed to seek a positive total return over a market cycle in U.S. dollars, regardless of market conditions, by investing primarily in global fixed income and derivative instruments. Under the prior investment objective, the Fund invested primarily in fixed income securities issued by companies or governments of any size, anywhere in the world. The Fund allocated assets across credit quality, structures, sectors, currencies and countries.

Risk

The risks of the Fund remain as discussed in the Fund's Simplified Prospectus.

The Fund is suitable for short- to medium-term investors seeking a U.S. dollar-denominated global fixed income fund to diversify a traditional portfolio of fixed income and equity investments, who can handle the volatility of bond markets and who have a low tolerance for risk.

The Fund is not available for purchase under registered plans, but taxable accounts may continue to purchase the Fund.

Results of Operations

Investment Performance

The performance of all series in the current and previous periods is shown in the *Past Performance* section of the report. Performance will vary by series primarily because fees and expenses differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Fund Formation and Series Information* section of this report for the varying management and administration fees payable by each series. The following comparison to market indices is intended to help investors understand the Fund's performance relative to the general performance of the markets. However, the Fund's mandate may be different from that of the indices shown.

During the period, the Fund's Series SC securities returned -3.2% (after deducting fees and expenses paid by the series). This compares with the ICE BofA US 3-Month Treasury Bill Index return of 0.1% and the ICE BofA Global Broad Market (Hedged) Index return of -4.1%. Effective June 4, 2021, the ICE BofA US 3-Month Treasury Bill Index (the "new index") replaced the ICE BofA Global Broad Market (Hedged) Index (the "previous index") to better represent the Fund's new investment objective (see *Investment Objective and Strategies*). All index and series returns are calculated on a total return basis in U.S. dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

Yields across the Group of Ten ("G10") countries experienced volatility in response to emerging COVID-19 variants, rising prices and escalating geopolitical tensions. Throughout the period, central banks generally became more aggressive, indicating an imminent departure from ultra-accommodative monetary policy. In turn, G10 yields steadily increased. Emerging market bonds had a strong start but ended the period weaker as yields of U.S. fixed income assets surged in anticipation of tightening U.S. Federal Reserve policy.

The Fund outperformed the previous index, with its shorter duration (lower sensitivity to interest rates) contributing to performance. Conversely, security selection among foreign government bonds detracted from performance.

The Fund underperformed the new index, with its exposure to corporate and government bonds detracting from performance.

The Fund held put options on a high-yield bond exchange-traded fund to mitigate credit risk, which detracted from performance relative to both indices. The Fund also held government bond futures to manage duration, which contributed to performance.

The Fund's foreign currency exposure was substantially hedged to the U.S. dollar, which contributed to performance as a result of the overall depreciation of the hedged currencies relative to the U.S. dollar.

Over the period, the Fund's exposure to China was decreased, while its exposure to Canada was increased. The Fund's exposure to term loans and corporate bonds was increased, while its exposure to foreign government bonds was decreased. These changes were made to align with the Fund's new investment objective. As a result, the Fund's cash position decreased.

Net Assets

The Fund's net assets decreased by 10.1% during the period to US\$23.7 million. This change was composed primarily of US\$0.7 million in net losses (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and a decrease of US\$1.9 million due to net securityholder activity (including sales, redemptions and cash distributions).

Fees and Expenses

The management expense ratio ("MER") for each series during the year ended March 31, 2022, was generally lower than the MER for the year ended March 31, 2021, due to a decrease in the management and/or administration fee rates effective June 4, 2021, as noted in the *Fund Formation and Series Information* section of the report. Total expenses paid also vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

Recent Developments

Ongoing uncertainty regarding the duration and long-term impact of the COVID-19 pandemic and the effectiveness of vaccines against new variants of the virus contributes to uncertainty regarding the timing of a full economic recovery. As a result, it is not possible to reliably estimate the impact of the pandemic on the financial results and condition of the Fund in future periods.

On June 4, 2021, the investment objective of the Fund was changed to more closely align with the investment objective of Mackenzie Unconstrained Fixed Income Fund (see *Investment Objective and Strategies*). This change provides investors with access to a U.S. dollar version of Mackenzie Unconstrained Fixed Income Fund.

At the same time, the Fund was renamed Mackenzie USD Unconstrained Fixed Income Fund and the management and/or administration fees on certain series were reduced to align with the management and administration fees of Mackenzie Unconstrained Fixed Income Fund.

The portfolio management team expects fixed income markets to remain volatile and inflation to stay high throughout 2022. The team further expects the Federal Reserve to remain aggressive in the face of persistent inflation, making a series of interest rate increases that could lead to additional uncertainty in the longer-term growth outlook. As such, the team was monitoring credit spreads (the difference in yield between government bonds and corporate bonds of similar maturities) and remained selective in identifying corporate bond opportunities at period-end.

The team believes the floating-rate term loan market offers good relative value, but issuer selection and sound credit research, among other factors, remain important in assessing investment opportunities.

Effective September 22, 2021, Atul Tiwari was appointed to the Mackenzie Funds' Independent Review Committee.

Related Party Transactions

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to the Manager at the annual rates specified under *Fund Formation and Series Information* in this report and as more fully described in the Prospectus. In return for the administration fees, the Manager pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not included in management fees. See also *Management Fees*.

Other Related Party Transactions

During the period, the Mackenzie Funds' Independent Review Committee issued a positive recommendation for the Fund to proceed with investing in a private credit fund managed by Northleaf Capital Partners, a company in which the Manager holds a significant ownership interest. At March 31, 2022, the Fund held an investment of US\$0.2 million (1.0% of the Fund's NAV) in Northleaf Private Credit II LP. This represents US\$0.2 million as part of a total commitment to invest US\$0.5 million.

During the period, the Mackenzie Funds' Independent Review Committee issued a positive recommendation for the Fund to proceed with investing in a private credit fund managed by Sagard Holdings Inc., a company affiliated with the Manager. At March 31, 2022, the Fund held an investment of US\$0.04 million (0.2% of the Fund's NAV) in Sagard Credit Partners II, LP as part of a total commitment to invest US\$0.5 million.

At March 31, 2022, Mackenzie had an investment of US\$0.01 million in the Fund (less than 0.1% of the Fund's NAV).

During the period, the Fund received US\$0.01 million in income distributions from investments in exchange-traded funds ("ETFs") managed by Mackenzie to offset fees paid within those ETFs. There is no assurance that these distributions will continue in the future.

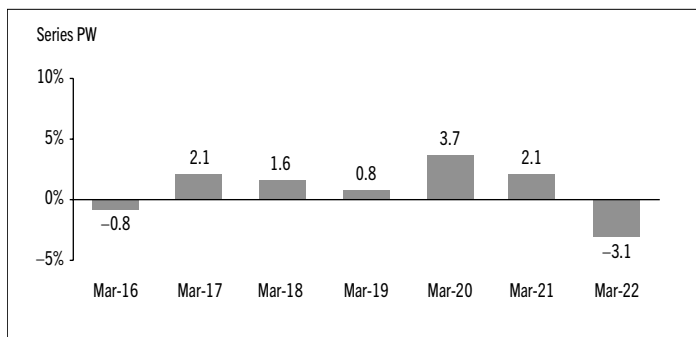
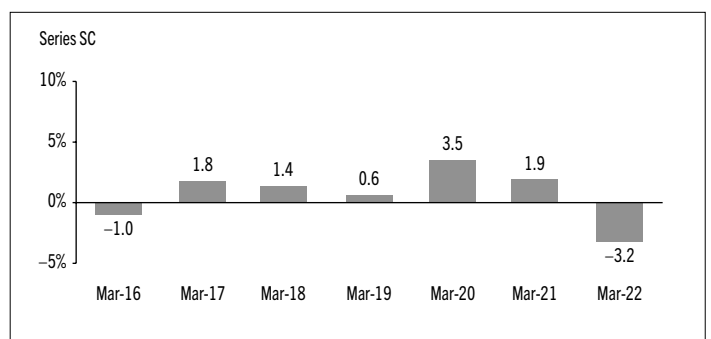
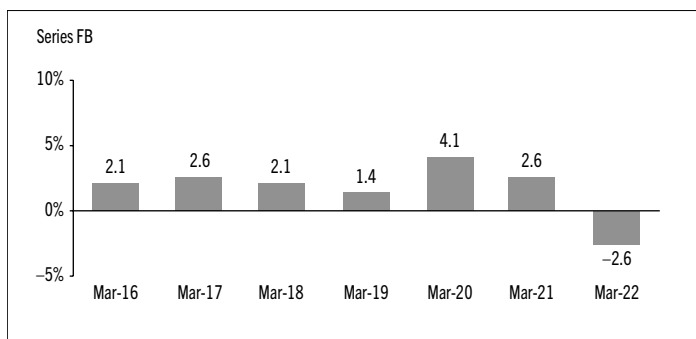
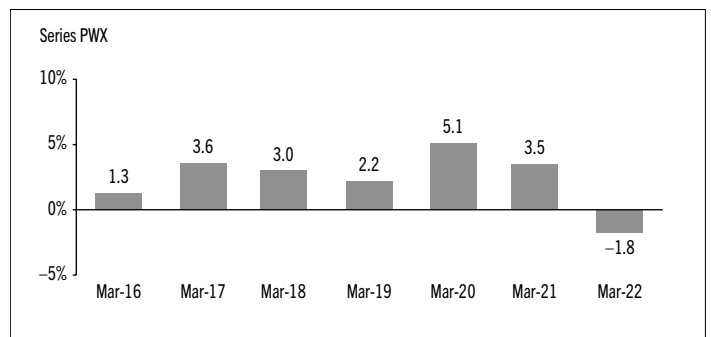
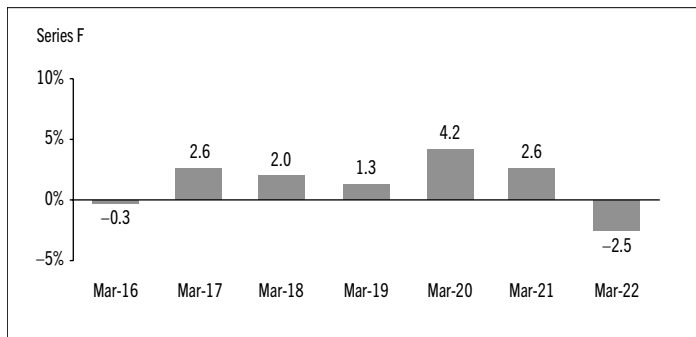

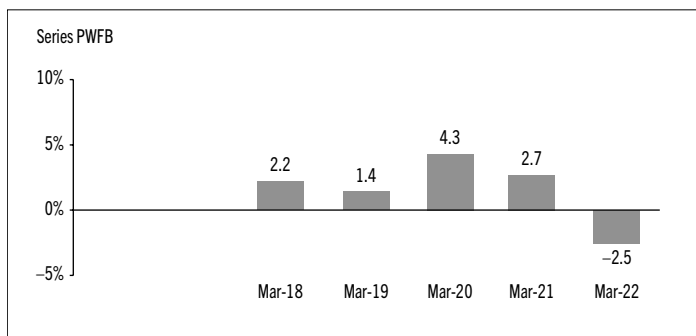
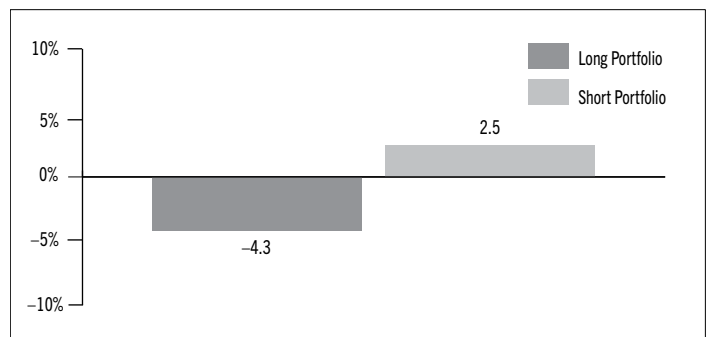

The ICE BofA Global Broad Market (Hedged) Index tracks the performance of investment grade debt publicly issued in major domestic and eurobond markets, including sovereign, quasi-government, corporate, securitized and collateralized securities. Qualifying bonds must be rated "BBB" or higher and have a remaining term to maturity of at least one year. The foreign currency exposure is hedged back to the U.S. dollar. In future reports, performance will no longer be compared to this index.

Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by the Manager to pay for the costs of managing the investment portfolio of the Fund and/or the underlying fund(s), as applicable, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, and providing other services. The Manager also used the management fees to fund sales commissions, trailing commissions and any other compensation (collectively "distribution-related payments") to registered dealers and brokers whose clients invest in the Fund.

The following dealers affiliated with the Manager may be entitled to distribution-related payments from the Manager on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation and Investors Group Financial Services Inc.

The Manager used approximately 44% of the total management fee revenues received from all Mackenzie funds during the period to fund distribution-related payments to registered dealers and brokers. In comparison, such distribution-related payments for the Fund represented on average 29% of the management fees paid by all applicable series of the Fund during the period. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series.

Series F securities are offered to investors who are enrolled in a dealer-sponsored fee-for-service or wrap program, who are subject to an asset-based fee rather than commissions on each transaction and who invest at least \$500; they are also available to employees of Mackenzie and its subsidiaries, and directors of Mackenzie.

Series FB securities are offered to retail investors investing a minimum of \$500. Investors are required to negotiate their advisor service fee, which cannot exceed 1.50%, with their financial advisor.

Series PW securities are offered through our Private Wealth Solutions to certain high net worth investors who invest a minimum of \$100,000.

Series PWFB securities are offered through our Private Wealth Solutions to certain high net worth investors who invest a minimum of \$100,000. Investors are required to negotiate their advisor service fee, which cannot exceed 1.50%, with their financial advisor.

Series PWX securities are offered through our Private Wealth Solutions to certain high net worth investors who invest a minimum of \$100,000. Investors are required to negotiate their advisor service fee, which cannot exceed 1.50%, with their financial advisor.

Series SC securities are offered to retail investors investing a minimum of \$500 under the sales charge purchase option.

Series F5, Series FB5, Series PWFB5 and Series PWT5 securities are no longer available for sale.

An investor in the Fund may choose among different purchase options that are available under each series. These purchase options are a sales charge purchase option, a redemption charge purchase option and various low-load purchase options. The charges under the sales charge purchase option are negotiated by investors with their dealers. The charges under the redemption charge and low-load purchase options are paid to Mackenzie if an investor redeems securities of the Fund during specific periods. Not all purchase options are available under each series of the Fund, and the charges for each purchase option may vary among the different series. All deferred sales charge purchase options will cease on or prior to June 2022. For further details on these purchase options, please refer to the Fund's Simplified Prospectus and Fund Facts.
