## **Management Discussion of Fund Performance**

June 4, 2024

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the Fund's performance and outlook in the year ended March 31, 2024 (the "period"). If the Fund was established during the period, "period" represents the period since inception.

In this report, "Mackenzie" and "the Manager" refer to Mackenzie Financial Corporation, the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

### **Investment Objective and Strategies**

The Fund seeks long-term capital growth by investing in a combination of equities and fixed income securities of issuers located anywhere in the world. The Fund invests primarily in the environmental economy supporting energy transition. The Fund will pursue this objective by investing in securities directly and/or by investing in other mutual funds.

#### Risk

The risks of the Fund remain as discussed in the Fund's Simplified Prospectus.

The Fund is suitable for medium- to long-term investors looking for a global balanced fund that invests in companies focused on sustainable investing to hold as part of their portfolio, who can handle the volatility of stock and bond markets, and who have a low to medium tolerance for risk.

#### Results of Operations

#### **Investment Performance**

The performance of all series in the current and previous periods is shown in the *Past Performance* section of the report. Performance will vary by series primarily because fees and expenses differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Fund Formation and Series Information* section of this report for the varying management and administration fees payable by each series. The following comparison to market indices is intended to help investors understand the Fund's performance relative to the general performance of the markets. However, the Fund's mandate may be different from that of the indices shown.

During the period, the Fund's Series A and Series LB securities returned -2.2% (after deducting fees and expenses paid by the series). This compares with a return of 14.2% for a blended index composed of a 50% weighting in the Fund's broad-based index, the MSCI AC (All Country) World (Net) Index (returned 23.3%), and a 50% weighting in the Bloomberg MSCI Green Bond (Hedged) Index (returned 5.6%). All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

Global equities rose over the period as central banks slowed the pace of interest rate increases. Gains in the U.S. equity market came largely from a small number of mega-capitalization stocks. The global economy was resilient, and employment remained strong. Inflation slowed but remained slightly above central bank targets. After July 2023, the U.S. Federal Reserve kept the federal funds rate at a target range of 5.25%–5.50%. Treasury yields reached peak levels and then fell in response to the policy shift. The Bank of Japan raised its policy rate for the first time in 17 years, but many central banks signalled potential rate cuts in 2024.

Within the MSCI AC (All Country) World (Net) Index, Poland, Colombia and Hungary were the strongest-performing markets in Canadian dollar terms, while Hong Kong, China and Thailand were the weakest. The information technology, communication services and financials sectors were the strongest performers, while consumer staples, utilities and real estate were the weakest.

The following discussion reflects the Fund's allocation decisions and the activities and performance of its underlying investment funds and other directly held securities. The Fund underperformed the broad-based index because of its allocation to fixed income securities, which underperformed equities in the period. Given the Fund's mandate, the return of the blended index is a more meaningful comparison.

The Fund underperformed the blended index, with the equity and fixed income portfolios underperforming the equity and fixed income portions of the blended index.

Within the equity portion of the Fund, stock selection in the United States, France, China, Canada and Germany detracted from performance. Overweight exposure to Portugal also detracted from performance. In sector terms, stock selection in information technology, industrials and materials detracted from performance, as did overweight exposure to utilities. Conversely, stock selection in Brazil and overweight exposure to Japan contributed to performance. In sector terms, lack of exposure to health care and real estate contributed to performance.

Within the fixed income portion of the Fund, the change in interest rates detracted from performance, particularly in foreign government bonds. Holdings in corporate bonds, particularly in the financial sector, detracted from performance. Conversely, currency management contributed to performance. The Fund held short government bond futures to manage duration (sensitivity to interest rates), which also contributed to performance.

Over the period, the Fund's exposure to fixed income increased, and the cash position decreased, as the fixed income portfolio management team found opportunities within foreign government bonds. Exposure to the United States increased.

#### Environmental, Social and Governance ("ESG") Impact

The equity portfolio management team has identified a growing opportunity for environmentally focused investment in large global and integrated utility companies. For that reason, the Fund has holdings in companies whose activities range from renewable energy development to transmission and distribution. Given increasing investments in clean energy relative to fossil fuels globally, the team believes diversified utility companies that invest a significant portion of their capital expenditures in renewable projects are positioned to pursue robust development pathways.

During the period, the team added a position in Carrier Global Corp. to the portfolio. Carrier is an American multinational company that manufactures heating, cooling and energy-efficient appliances, and is one of the global leaders in heat pump production. In the coming decades, heat pumps are expected to greatly increase their market share of appliances to serve the energy needs of homes. Because most heat pumps are powered by electricity, they produce fewer carbon emissions than appliances using fossil fuels. Utilizing a heat pump, rather than a traditional oil- or gas-fired furnace and/or air conditioning unit, can also boost the energy efficiency of the average home significantly. Energy efficiency is the one of the team's six primary areas of environmental focus.

The equity team also added a position in Centrais Elétricas Brasileiras SA - Eletrobras, which is one of the largest utility companies in South America. Eletrobras generates over half of Brazil's electricity supply, almost entirely from hydropower, and operates a significant portion of the country's transmission network. Its operations facilitate not only the effective and efficient transportation of electricity but also the adoption of renewable energy.

Over the period, the fixed income portfolio significantly increased its position in the inaugural green bond from the Government of New Zealand (4.25%, 05-15-2034), which will finance transition themes such as clean transport, energy efficiency, renewable energy, green buildings, living and natural resources, and land use.

The country's Green Bond Framework supports the continued financing of the environmental objectives highlighted in New Zealand's 2022–2025 Emission Reduction Plan. Further, the framework highlights the importance of an intersectional approach to sustainability, emphasizing the role of traditional Maori (Indigenous) philosophies and leadership in the country's environmental and economic transition to net zero greenhouse gas emissions. New Zealand is a leader in ESG factors according to the fixed income team's sovereign sustainability models.

The portfolio also significantly increased its position in a green bond issued by Bruce Power LP (2.68%, 12-21-2028). In 2022, nuclear power provided 54% of Ontario's electricity output, with 29% of nuclear generation coming from Bruce Power. Nuclear power is a relatively new project category for green bonds. Because it emits no greenhouse gases, nuclear is a reasonable replacement for baseload power coming from coal-fired and gas-fired power generation. According to the Canada Energy Regulator, electricity generation needs to at least double from current levels by 2050 given the general electrification of the economy required to achieve net zero, as well as to facilitate the adoption of electric vehicles.

Over the period, the proportion of ESG-labelled debt increased to 84% from 81% of the portfolio's fixed income investments. Green bonds increased to 66% from 48%, sustainable bonds decreased to 12% from 14%, sustainability-linked bonds decreased to 3% from 9%, and social bonds increased to 2% from 1%. Transition bonds, which fund a company's transition toward reduced environmental impact or lower carbon emissions, increased to 1% from 0%. The remaining 16% of the portfolio's fixed income investments had issuers the team considers to be ESG leaders relative to their peers.

#### **Net Assets**

The Fund's net assets increased by 29.6% during the period to \$188.9 million. This change was composed primarily of \$1.7 million in net losses (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and an increase of \$44.8 million due to net securityholder activity (including sales, redemptions and cash distributions).

#### **Fees and Expenses**

The management expense ratio ("MER") for each series during the year ended March 31, 2024, was generally similar to the MER for the year ended March 31, 2023. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

#### Recent Developments

The equity portfolio management team expects interest rate cuts to continue at a slower pace than market expectations because of persistent inflation in developed markets, particularly the United States. Geopolitical issues worsened over the period, in the team's opinion, as the wars in Gaza and Ukraine became more deeply entrenched, and global oil prices increased as a result. However, the team believes developments in the U.S. offshore wind power sector offered some early indications that regulatory-related repricing may allow some developers to restart projects that were cancelled in 2023.

The fixed income portfolio management team believes that robust economic data and elevated inflation at period-end have diminished earlier market expectations for U.S. Federal Reserve policy easing, and the team has a neutral view on duration in the United States. Given weakening economic indicators and restrictive financial conditions, which may lead to more accommodative monetary policy, the team favours duration in Canada. The team expects opportunities to increase the portfolio's Canadian duration during selloffs when market pricing underestimates policy rate reductions.

### **Management and Administration Services**

For each applicable series, the Fund paid management fees and administration fees to the Manager at the annual rates specified under *Fund Formation and Series Information* in this report and as more fully described in the Prospectus. In return for the administration fees, the Manager pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not included in management fees. See also *Management Fees*.

#### Other Related Party Transactions

At March 31, 2024, Mackenzie had an investment of \$0.3 million in the Fund (0.2% of the Fund's NAV).

The Fund did not rely on an approval, positive recommendation or standing instruction from the Mackenzie Funds' Independent Review Committee with respect to any related party transactions in the period.

An independent research driven methodology is used to evaluate index-eligible green bonds to ensure they adhere to established Green Bond Principles and to classify bonds by their environmental use of proceeds. The foreign currency exposure is hedged back to the Canadian dollar.

### **Management Fees**

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by the Manager to pay for the costs of managing the investment portfolio of the Fund and/or the underlying fund(s), as applicable, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, and providing other services. The Manager also used the management fees to fund sales commissions, trailing commissions and any other compensation (collectively "distribution-related payments") to registered dealers and brokers whose clients invest in the Fund.

LBC Financial Services Inc. ("LBC") is the principal distributor for the LBC series securities of the Fund (as listed under *Fund Formation and Series Information*) and receives a portion of the management fees that the Fund pays to the Manager. Under this arrangement, LBC was entitled to approximately 25% of the total management fees that the Manager received from the LBC series of all Mackenzie funds during the period. The Manager is responsible for paying all distribution-related payments to LBC-authorized dealers whose clients invest in the LBC series of the Fund.

The following dealers affiliated with the Manager may be entitled to distributionrelated payments from the Manager on the same basis as unrelated registered brokers and dealers: Investors Group Securities Inc. and Investors Group Financial Services Inc.

The Manager used approximately 42% of the total management fee revenues received from all Mackenzie funds during the period to fund distribution-related payments to registered dealers and brokers. In comparison, such distribution-related payments for the Fund represented on average 33% of the management fees paid by all applicable series of the Fund during the period. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series.

Series AR securities are offered to retail investors in a Registered Disability Savings Plan offered by Mackenzie.

Series D securities are offered to retail investors investing a minimum of \$500 through a discount brokerage or other account approved by Mackenzie.

Series F, Series F5 and Series F8 securities are offered to investors who are enrolled in a dealer-sponsored fee-for-service or wrap program, who are subject to an asset-based fee rather than commissions on each transaction and who invest at least \$500 (\$5,000 for Series F5 and Series F8); they are also available to employees of Mackenzie and its subsidiaries, and directors of Mackenzie. Series PW, Series PWT5 and Series PWT8 securities are offered through our Private Wealth Solutions to certain high net worth investors who invest a minimum of \$100,000. Investors in Series PWT5 and Series PWT8 securities also want to receive a monthly cash flow of 5% or 8% per year, respectively.

Series PWFB and Series PWFB5 securities are offered through our Private Wealth Solutions to certain high net worth investors who invest a minimum of \$100,000. Investors are required to negotiate their advisor service fee, which cannot exceed 1.50%, with their financial advisor. Investors in Series PWFB5 securities also want to receive a monthly cash flow of 5% per year.

Series PWR securities are offered through our Private Wealth Solutions to certain high net worth investors who invest a minimum of \$100,000 in a Registered Disability Savings Plan offered by Mackenzie.

Series PWX and Series PWX8 securities are offered through our Private Wealth Solutions to certain high net worth investors who invest a minimum of \$100,000. Investors are required to negotiate their advisor service fee, which cannot exceed 1.50%, with their financial advisor. Investors in Series PWX8 securities also want to receive a monthly cash flow of 8% per year.

Series LW and Series LW5 securities are offered through our Preferred Pricing Program to certain high net worth investors who invest a minimum of \$100,000. Investors in Series LW5 securities also want to receive a monthly cash flow of 5% per year.

Effective June 1, 2022, an investor may purchase the Fund under a sales charge purchase option and a no-load purchase option. Not all purchase options are available under each series of the Fund. The sales charge under the sales charge purchase option is negotiated by the investor with their dealer. Securities purchased before June 1, 2022, under the redemption charge purchase option, low-load 3 purchase option and low-load 2 purchase option (collectively the "deferred sales charge purchase options") may continue to be held in investor accounts. Investors may switch from securities of a Mackenzie fund previously purchased under these deferred sales charge purchase options to securities of other Mackenzie funds, under the same purchase option, until such time as the redemption schedule has expired.
