## Management Discussion of Fund Performance

July 13, 2020

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments during the year ended March 31, 2020 (the "period"), that have affected the ETF's performance and outlook. If the ETF was established during the period, "period" represents the period from inception to the end of the fiscal period. For information on the ETF's longer-term performance, as applicable, please refer to the *Past Performance* section of the report. In this report, "Mackenzie" refers to Mackenzie Financial Corporation, the manager of the ETF. In addition, net asset value ("NAV") refers to the value of the ETF as calculated for subscription and redemption purposes, on which the discussion of ETF performance is based.

### Investment Objective and Strategies

The ETF seeks long-term capital growth, consistent with protection of capital, by investing primarily in a broad range of equities within developed markets anywhere in the world. The ETF's investments may include investments in emerging markets, and securities of U.S. companies will usually form the largest percentage of assets from any geographic area.

### Risk

The risks of the ETF remain as discussed in the ETF's Prospectus.

The ETF is suitable for medium- to long-term investors looking for a global equity fund to hold as part of their portfolio, who can handle the volatility of stock markets and who have a low to medium tolerance for risk. Before June 28, 2019, the ETF was deemed suitable for investors who had a medium tolerance for risk.

### Results of Operations

#### Investment Performance

During the period, the ETF returned  $-4.3\%$  (after deducting fees and expenses). This compares with the MSCI World (Net) Index return of  $-5.5\%$ . All index returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

Global equity markets rallied strongly into February despite weakening economic data, particularly within the manufacturing sector. Declining interest rates and the "phase one" trade deal reached between the United States and China provided hope for a recovery in global gross domestic product growth. However, global equities fell sharply in March in response to the worldwide health measures put into place to mitigate the impact of the COVID-19 pandemic. A weaker Canadian dollar late in the period boosted returns for Canadian investors.

Within the MSCI World (Net) Index, Denmark, Switzerland and New Zealand were the strongest-performing countries in Canadian dollar terms, while Austria, Norway and Belgium were the weakest. From a sector perspective, information technology, health care and utilities were the strongest performers, while energy, financials and materials were the weakest.

The ETF outperformed the index, with an overweight position and stock selection in the consumer staples sector, and an underweight position and stock selection in the financials sector, contributing to performance. On a country level, stock selection in the United Kingdom, Japan and Canada contributed to performance.

Detractors from performance included an underweight position and stock selection in the information technology sector, as well as stock selection in the communication services and health care sectors. On a country level, stock selection in Hong Kong and underweight exposure to Switzerland detracted from performance.

The ETF's foreign currency exposure was not hedged. Currency exposure contributed to the performance of both the ETF and the index primarily as the U.S. dollar appreciated relative to the Canadian dollar.

Over the period, exposure to Japan was increased due to attractive valuations following the market decline. Market effect and portfolio activity resulted in decreased exposure to the United States and the elimination of exposure to Australia. Changes to the portfolio included new positions in Kao Corp. and Unicharm Corp., and the elimination of the position in Bridgestone Corp.

### Net Assets

The ETF's NAV increased by 120.6% to \$29.4 million at March 31, 2020, from \$13.3 million at March 31, 2019. This change was composed primarily of \$2.6 million in net losses (after including dividend and interest income) from investment performance, after deducting fees and expenses, \$18.8 million in net sales, and \$0.2 million in cash distributions.

At March 31, 2020, 20.0% of the ETF's NAV was held by investors that individually owned 10% or more of the ETF. As a result of these investments, the ETF is subject to large transaction risk as discussed in the Prospectus. Mackenzie manages this risk to reduce the possibility of any adverse effect on the ETF or on its investors, through such processes as settling transactions in kind, charging creation and/or redemption fees for transactions settling in cash, and establishing appropriate order cut-off times for transactions.

### Recent Developments

Governments worldwide have enacted emergency measures to combat the spread of the COVID-19 virus in the last several months. These measures have caused significant volatility and weakness in global equity markets and material disruption to businesses globally, resulting in an economic slowdown. Governments and central banks have reacted with significant monetary and fiscal interventions designed to stabilize economic conditions.

The duration and impact of the COVID-19 pandemic on businesses and markets, and the extent of economic relief measures provided by governments and central banks, are unknown at the reporting date and it is therefore not possible to reliably estimate the impact on the financial results and position of the ETF in future periods.

The portfolio management team believes elevated debt and asset prices at the market peak in February compounded the impact of subsequent market volatility due to COVID-19. Although the team believes additional, possibly severe, secondary effects from the COVID-19 crisis are likely, the team also believes that potential market appreciation exceeds the risk of further declines over the longer term. Therefore, the team took the opportunity to add positions in securities that became attractively valued as markets declined.

## Related Party Transactions

The following arrangements result in fees paid by the ETF to Mackenzie or to companies affiliated with the ETF.

## Management Fees

The management expense ratio ("MER") for the ETF of 0.84% during the year ended March 31, 2020, was lower than the MER of 0.89% for the year ended March 31, 2019, due to a decrease in fund costs and a decrease in the management fee rate. On October 10, 2018, the management fee paid by the ETF to Mackenzie decreased to an annual rate of 0.75% from 0.85%.

The management fee for the ETF is calculated and accrued daily as a percentage of its NAV. The ETF's management fees were used by Mackenzie to pay for the costs of managing the investment portfolio of the ETF, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio and providing other services, and to pay for all costs and expenses (other than certain specified fund costs as more fully described in the Prospectus) required to operate the ETF.

## Other Related Party Transactions

Investment funds managed by Mackenzie invest in the ETF in accordance with the investment objectives of those funds. At March 31, 2020, funds managed by Mackenzie owned 7.3% of the ETF's NAV. All related party transactions are based on the current market price.

The ETF did not rely on an approval, positive recommendation or standing instruction from the Mackenzie Funds' Independent Review Committee with respect to any related party transactions.

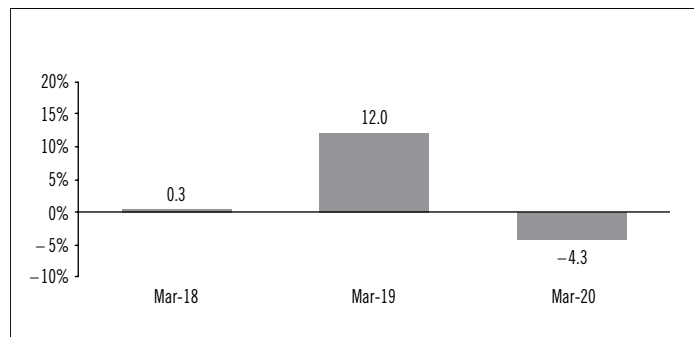
## Past Performance

The ETF's past performance information is presented in the following chart and table. It assumes all distributions made by the ETF in the periods presented are reinvested in additional units of the ETF. The chart and table do not take into account brokerage commissions or income taxes payable by any investor that would have reduced returns. Mackenzie may waive or absorb operating expenses at its discretion and stop waiving or absorbing such expenses at any time without notice.

(3) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period. Mackenzie may reimburse the ETF for certain brokerage commissions and other transaction costs (including those payable to the custodian or its agents). Mackenzie may make these reimbursements at its discretion and stop these reimbursements at any time without notice.

(4) The ETF's portfolio turnover rate indicates how actively the ETF's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the ETF buying and selling all of the securities in its portfolio once in the course of the period. The higher an ETF's portfolio turnover rate in a period, the greater the trading costs payable by the ETF in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of an ETF. The portfolio turnover rate is not provided when the ETF is less than one year old.
