Management Discussion of Fund Performance

November 11, 2022

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the ETF's performance and outlook in the six-month period ended September 30, 2022 (the "period"). If the ETF was established during the period, "period" represents the period since inception.

In this report, "Mackenzie" and "the Manager" refer to Mackenzie Financial Corporation, the manager of the ETF. In addition, net asset value ("NAV") refers to the value of the ETF as calculated for subscription and redemption purposes, on which the discussion of ETF performance is based.

Results of Operations

Investment Performance

During the period, the ETF returned -13.6% (after deducting fees and expenses). This compares with a return of -14.3% for the ETF's broad-based index, the MSCI EAFE (Net) Index, and a return of -13.3% for the ETF's narrow index, the TOBAM Maximum Diversification All World Developed ex North America Index. All index returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

Russia's invasion of Ukraine continued to constrain the European economy over the period. Energy prices remained elevated as Russian supplies of natural gas fell sharply. Consequently, European inflation was high and bond yields rose significantly. The European Central Bank raised its policy rate to combat surging inflation. In Japan, stocks declined, and the yen fell against the U.S. dollar to its lowest level in more than 20 years. In China, pandemic-related lockdowns, geopolitical uncertainty and a slowing housing market led to lower-than-expected economic growth and steep declines in equities.

The ETF's core investment philosophy is to seek enhanced diversification through a balanced exposure to all relevant risk factors in the non-North American developed country equity markets. As a result of this approach, the ETF may have less concentrated risk exposures than those of a market capitalization weighted index, such as the broad-based index.

The ETF outperformed the broad-based index, with stock selection in Japan and Hong Kong contributing to performance. In sector terms, an underweight position and stock selection in information technology and stock selection in industrials contributed to performance.

Conversely, stock selection in the United Kingdom and France detracted from performance relative to the broad-based index. In sector terms, underweight exposure to energy and stock selection in consumer staples detracted from performance.

Given the ETF's mandate, the return of the narrow index is a more meaningful comparison. The difference in performance between the ETF and the narrow index resulted primarily from management fees and other operating expenses.

Over the period, changes were made to the ETF's holdings to reflect changes in the composition of the narrow index.

Net Assets

The ETF's net assets decreased by 26.6% during the period to \$45.8 million. This change was composed primarily of \$8.0 million in net losses (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and a decrease of \$8.6 million due to net unitholder activity (including sales, redemptions and cash distributions).

Recent Developments

Because the ETF is an index fund, neither market expectations nor recent developments affect the composition of the portfolio.

Related Party Transactions

Management Fees

The annualized management expense ratio ("MER") for the ETF during the period ended September 30, 2022, was similar to the MER for the year ended March 31, 2022. Total expenses paid vary from period to period mainly as a result of changes in average assets in the ETF. The MERs are presented in the *Financial Highlights* section of this report. The ETF paid management fees to the Manager at the annual rate of 0.50%.

The management fee for the ETF is calculated and accrued daily as a percentage of its NAV. The ETF's management fees were used by the Manager to pay for the costs of managing the investment portfolio of the ETF, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, providing other services and licensing the index, and to pay for all costs and expenses (other than certain specified fund costs as more fully described in the Prospectus) required to operate the ETF.

Other Related Party Transactions

The Manager is wholly owned by IGM Financial Inc., which in turn is a subsidiary of Power Corp. of Canada. Companies related to Power Corp. of Canada are therefore considered affiliates of the Manager. At September 30, 2022, the ETF held the following investment(s) in companies affiliated with the Manager: \$0.1 million invested in securities issued by Pernod Ricard SA and \$0.02 million invested in securities issued by Umicore SA. The investment(s) represented 0.2% of the ETF's NAV. In making the investment(s), the Manager relied on the approval of the Mackenzie Funds' Independent Review Committee. The Independent Review Committee issued the approval on the basis that the investment(s) would be made in compliance with the Manager's policies. The Manager's policies are designed to ensure that any related party transaction (i) is made free from any influence by an entity related to the Manager and without taking into account any considerations relevant to an entity related to the Manager; (ii) represents the business judgment of the Manager, uninfluenced by considerations other than the best interests of the ETF; and (iii) achieves a fair and reasonable result for the ETF.

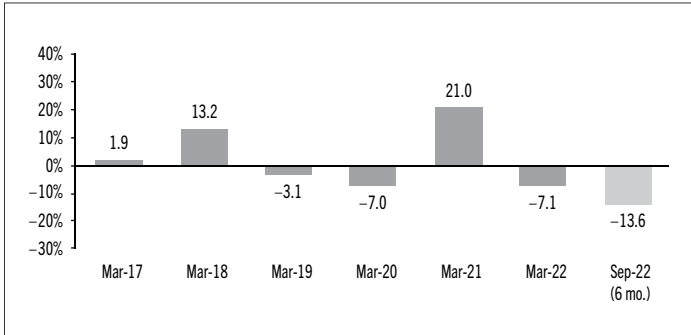
Investment funds managed by Mackenzie and its affiliates may invest in the ETF in accordance with the investment objectives of those funds. At September 30, 2022, funds managed by Mackenzie owned 19.8% of the ETF's NAV. All related party transactions are based on the current market price. As a result of these investments, the ETF may be subject to large transaction risk as discussed in the Prospectus. Mackenzie manages this risk to reduce the possibility of any adverse effects on the ETF or on its investors, through such processes as settling transactions in kind, charging creation and/or redemption fees for transactions settling in cash, and establishing appropriate order cut-off time for transactions.
