*The Fund is a class of Mackenzie Financial Capital Corporation.

The AIF is amended to reflect the following changes that were effective May 19, 2020:

1. The name of Mackenzie Global Small Cap Fund was changed to Mackenzie Global Small-Mid Cap Equity Fund.
2. The name of Mackenzie Global Small Cap Class was changed to Mackenzie Global Small-Mid Cap Equity Class.
3. The investment strategies of the Funds were changed.
4. The portfolio manager of the Funds was changed.
5. Confirm amendment to the Simplified Prospectus and Fund Facts in respect of the Funds.

- a) By deleting all references to “Mackenzie Global Small Cap Fund” and replacing them with “Mackenzie Global Small-Mid Cap Equity Fund”.
- b) By adding the footnote indicator “41” next to Mackenzie Global Small-Mid Cap Equity Fund” on the front cover of the AIF.
- c) By adding the following next to footnote indicator “41” at the bottom of the front cover of the AIF:

“Prior to May 19, 2020, “Mackenzie Global Small Cap Fund”.”
- d) On page 10, by deleting the row corresponding to Mackenzie Global Small Cap Fund and inserting the following:

- e) By deleting all references to “Mackenzie Global Small Cap Class” and replacing them with “Mackenzie Global Small-Mid Cap Equity Class”.
- f) By adding the footnote indicator “42” next to Mackenzie Global Small-Mid Cap Equity Class” on the front cover of the AIF.
- g) By adding the following next to footnote indicator “42” at the bottom of the front cover of the AIF:

“Prior to May 19, 2020, “Mackenzie Global Small Cap Class”.”
- h) On page 10, by deleting the row corresponding to Mackenzie Global Small Cap Class and inserting the following:
