

**AMENDMENT NO. 2 DATED JANUARY 4, 2021 TO THE
ANNUAL INFORMATION FORM DATED SEPTEMBER 25, 2020, AS
AMENDED BY AMENDMENT NO. 1 DATED NOVEMBER 9, 2020**

The AIF is amended to reflect the acquisition of Greenchip Financial Corp. (“Greenchip”) including its portfolio managers. As a result, effective January 1, 2021, Greenchip is removed as sub-advisor for the Fund, the Greenchip portfolio managers responsible for the Fund are now with Mackenzie, to remove all references and ancillary disclosure related to Greenchip and to confirm amendments to the fund facts for the Fund.

- 1) By removing all references and ancillary disclosure relating to Greenchip.
