Mackenzie Financial Corporation ("**Mackenzie**") is writing to notify you that special meetings of unitholders (the "**Meetings**") of Mackenzie Multi-Strategy Absolute Return Fund and Mackenzie Credit Absolute Return Fund (the "**Funds**") will be held concurrently at Mackenzie's offices on the 11<sup>th</sup> floor of 180 Simcoe Street, Toronto, Ontario, on May 31, 2024, at 9:00 a.m. (Toronto Time).

### **Notice-and-Access**

Pursuant to exemptive relief, we have opted to use a notice-and-access procedure to reduce the volume of paper in the materials distributed for the Meetings. Instead of sending you a printed copy of the management information circular, we have enclosed the form of proxy, or voting instruction form, with this notice, which outlines the procedures for accessing the management information circular online or requesting a paper or electronic copy to be sent to you free of charge. ## **Independent Review Committee**

The Independent Review Committee ("IRC") of the Funds has reviewed the Proposed Merger, as described in the management information circular, and has determined that the Proposed Merger, if implemented, would achieve a fair and reasonable result for each of the Funds.

While the IRC has determined that the implementation of the Proposed Merger would achieve a fair and reasonable result for each of the Funds, it is not the role of the IRC to recommend that unitholders vote in favour of each of the Proposed Merger.

Unitholders should review the Proposed Merger described in the management information circular and make their own decisions.

### Voting

You may vote your units by mail, fax, online or in person at the Meeting(s). Please refer to the directions on your proxy or voting instruction form for instructions on how to vote using these methods.

Unitholders who are entitled to vote, but are unable to attend the Meeting(s) in person, are requested to exercise their right to vote by completing, dating, signing and returning the form of proxy to Proxy Processing, 4102-1380 Rodick Rd, Markham ON L3R 9Z9 or by facsimile to Doxim at 1-888-496-1548 (toll free) so that it arrives before May 30, 2024, at 5:00 p.m. (Toronto Time). An addressed pre-paid envelope has been provided for your use. Alternatively, unitholders may vote online by accessing <a href="https://www.secureonlinevote.com">www.secureonlinevote.com</a> and entering the 12-digit control number that is located on the form of proxy and following the simple instructions on that website.

You also can request a copy of the management information circular up to one year after the date of this letter, and in which case, if we receive your request after May 31, 2024, then we will send it to you within 10 calendar days.
