Management Discussion of Fund Performance

June 3, 2019

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments during the period ended March 31, 2019, that have affected the Fund's performance and outlook. If the Fund was established during the period, "period" represents the period from inception to the end of the fiscal period. For information on the Fund's longer-term performance, as applicable, please refer to the *Past Performance* section of the report. In this report, "Mackenzie" refers to Mackenzie Financial Corporation, the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

Investment Objective and Strategies

The Fund seeks income and some long-term capital growth by investing primarily in one or more mutual funds that invest in Canadian and foreign fixed income securities and other asset categories, although it may also invest in securities directly. The Fund diversifies in terms of geographic exposure, sector exposure, portfolio manager style, credit quality and duration.

Risk

The risks of the Fund remain as discussed in the Fund's Simplified Prospectus.

The Fund is suitable for short- to medium-term investors looking for a managed asset portfolio fund to hold as part of their portfolio, who can handle the volatility of bond markets and who have a low tolerance for risk.

Results of Operations

Investment Performance

The performance of the Fund's Series A and Series LB securities is discussed below. The performance of all series is shown in the *Past Performance* section of the report. Where series returns differ, it is primarily because different levels of fees and expenses were charged to each series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Fund Formation and Series Information* section of this report for the varying management and administration fees payable by each series.

During the year, the Fund's Series A securities returned 4.0%, and Series LB securities returned 3.9% (after deducting fees and expenses paid by the series). This compares with a return of 5.2% for a blended index composed of a 90% weighting in the Fund's broad-based index, the FTSE Canada Universe Bond Index (returned 5.3%), and a 10% weighting in the ICE BofAML Global Broad Market (Hedged) Index (returned 4.1%). All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

Performance varied across developed global sovereign bond markets. In general, yields on longer-term bonds declined and yield curves flattened as central banks took a more pessimistic view of growth as the year progressed. Emerging markets stabilized in January after the U.S.

Federal Reserve shifted away from monetary tightening, introducing some uncertainty about the strength of the U.S. dollar. High-yield credit spreads (the difference in yield between investment grade and high-yield bonds of similar maturities) widened slightly over the year. The Canadian bond market outperformed the broader global bond market during the year. Despite volatility, the Canadian dollar was relatively strong, benefiting from a solid economic backdrop.

The following discussion reflects the Fund's allocation decisions and the activities and performance of its underlying mutual funds and other directly held securities. The Fund underperformed the broad-based index, with longer-duration government bonds detracting from performance as their yields fell less than yields of mid-term bonds. Given the Fund's mandate, the return of the blended index is a more meaningful comparison.

The Fund underperformed the blended index, with underweight exposure to government bonds and overweight exposure to corporate bonds detracting from performance. Conversely, security selection in corporate bonds, particularly in the industrial and energy sectors, and exposure to term loans contributed to performance.

Active management of foreign currency exposure detracted from performance. The Fund had overweight exposure to the euro earlier in the year as it depreciated relative to the Canadian dollar.

The Fund held short U.S. 10-year bond futures to mitigate the possibility of rising yields and because the portfolio management team believed valuations appeared high, which detracted from performance. The Fund held long equity futures to help improve the long-term risk-reward characteristics of a pure fixed income portfolio, which contributed to performance.

Over the year, portfolio activity and market effect resulted in decreased exposure to fixed income. Exposure to Canada and Germany increased, while exposure to the United States, the United Kingdom and Australia decreased. At the sector level, exposure to federal bonds and foreign government bonds increased, while exposure to corporate bonds and term loans decreased.

Changes to the portfolio included a new allocation to Mackenzie Multi-Strategy Absolute Return Fund and the elimination of the allocations to Symmetry Comprehensive Equity Fund, iShares iBoxx \$ Investment Grade Corporate Bond ETF and iShares Canadian Corporate Bond Index ETF.

Net Assets

The Fund's NAV increased by 19.8% to \$202.6 million at March 31, 2019, from \$169.0 million at March 31, 2018. This change was composed primarily of \$8.0 million in net income (including dividend and interest income) from investment performance, after deducting fees and expenses, \$25.7 million in net sales, and \$0.2 million in cash distributions.

Fees and Expenses

The management expense ratios ("MERs") for Series A of 1.27% and for Series LB of 1.33% during the year ended March 31, 2019, were unchanged from the MERs for the year ended March 31, 2018. The MERs (before and after waivers or absorptions, if any) for all series are presented in the *Financial Highlights* section of this report.

Recent Developments

Most developed countries have shifted away from monetary tightening while expressing more tolerance for allowing inflation to exceed target levels. In the view of the Mackenzie Multi-Asset Strategy team, unless U.S. domestic growth and markets rise significantly, the Federal Reserve is unlikely to raise rates in 2019. Despite this change in outlook, the team does not anticipate a recession in 2019, but expects economic activity to pick up. The team believes the European Central Bank and the Bank of Japan will keep monetary conditions accommodative as confidence in their respective economies falters. The team expects the Bank of Canada to continue relying on Canadian economic data but also to consider U.S. monetary policy and interest rate decisions.

Effective June 1, 2018, Series PWF securities were consolidated into Series F securities, and Series PWF6 securities were consolidated into Series F6 securities.

Effective January 1, 2019, Series F6 was renamed Series F5, Series PWT6 was renamed Series PWT5, Series T6 was renamed Series T5 and Series LW6 was renamed Series LW5, and the fixed-rate distributions of these series changed from 6% to 5%. On the same date, the fixed-rate distribution of Series LX also changed from 6% to 5%.

To align with new securities regulations, Mackenzie updated the investment objective and strategies of underlying fund Mackenzie Multi-Strategy Absolute Return Fund effective January 11, 2019. These changes provide additional flexibility for using derivatives, short selling and borrowing.

On March 19, 2019, the Mackenzie Fixed Income team assumed responsibility for portfolio management of the entire portfolio of underlying fund Symmetry Canadian Bond Fund.

Related Party Transactions

The following arrangements result in fees paid by the Fund to Mackenzie or to companies affiliated with the Fund.

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Mackenzie at the annual rates specified under *Fund Formation and Series Information* in this report and as more fully described in the Prospectus. In return for the administration fees, Mackenzie pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not included in management fees. See also *Management Fees*.

Other Related Party Transactions

At March 31, 2019, Mackenzie had an investment of \$15,011 in the Fund (less than 0.1% of the Fund's NAV).

The Fund did not rely on an approval, positive recommendation or standing instruction from the Mackenzie Funds' Independent Review Committee with respect to any related party transactions.

Past Performance

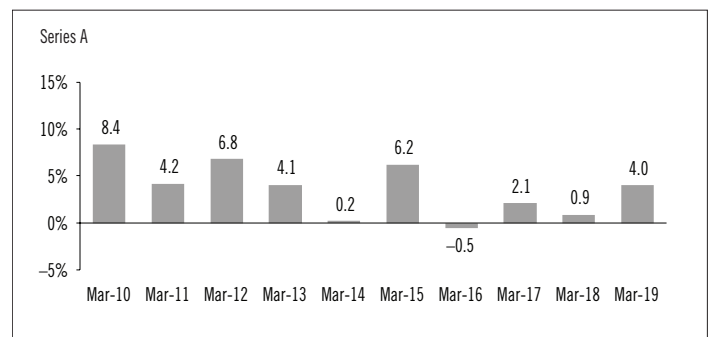
The Fund's past performance information is presented in the following charts and table. On September 28, 2012, the Fund changed its mandate to invest primarily in other mutual funds to gain exposure to Canadian and foreign fixed income securities and other asset classes, rather than investing mainly in fixed income securities directly. The past performance before this date was achieved under the previous objectives.

The FTSE Canada Universe Bond Index is a broad measure of Canadian bonds with terms to maturity of more than one year. It includes federal, provincial, municipal and corporate bonds rated "BBB" or higher.

The ICE BofAML Global Broad Market (Hedged) Index tracks the performance of investment grade debt publicly issued in the major domestic and eurobond markets, including sovereign, quasi-government, corporate, securitized and collateralized securities. Qualifying bonds must be rated "BBB" or higher and have a remaining term to maturity of at least one year. The foreign currency exposure is hedged back to the Canadian dollar.

Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by Mackenzie to pay for the costs of managing the investment portfolio of the Fund and/or the underlying fund(s), as applicable, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, and providing other services. Mackenzie also used the management fees to fund sales commissions, trailing commissions and any other compensation (collectively "distribution-related payments") to registered dealers and brokers whose clients invest in the Fund.

LBC Financial Services Inc. ("LBC") is the principal distributor for the LBC series securities of the Fund (as listed under *Fund Formation and Series Information*) and receives a portion of the management fees that the Fund pays to Mackenzie. Under this arrangement, LBC was entitled to approximately 23% of the total management fees that Mackenzie received from the LBC series of all Mackenzie funds during the year. Mackenzie is responsible for paying all distribution-related payments to LBC-authorized dealers whose clients invest in the LBC series of the Fund.

The following dealers affiliated with Mackenzie may be entitled to distribution-related payments from Mackenzie on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation and Investors Group Financial Services Inc.

Mackenzie used approximately 43% of the total management fee revenues received from all Mackenzie funds during the year to fund distribution-related payments to registered dealers and brokers. In comparison, such distribution-related payments for the Fund represented on average 39% of the management fees paid by all applicable series of the Fund during the year. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series.

Series AR securities are offered to retail investors in a Registered Disability Savings Plan offered by Mackenzie.

Series D securities are offered to retail investors investing a minimum of \$500 through a discount brokerage or other account approved by Mackenzie.

Series F and Series F5 securities are offered to investors who are enrolled in a dealer-sponsored fee-for-service or wrap program, who are subject to an asset-based fee rather than commissions on each transaction and who invest at least \$500 (\$5,000 for Series F5); they are also available to employees of Mackenzie and its subsidiaries, and directors of Mackenzie. Investors in Series F5 securities also want to receive a monthly cash flow of 5% per year. Before January 1, 2019, Series F5 securities were known as Series F6.

Series FB securities are offered to retail investors investing a minimum of \$500. Investors are required to negotiate their advisor service fee, which cannot exceed 1.50%, with their financial advisor.

Series O securities are offered only to investors investing a minimum of \$500,000 who are enrolled in Mackenzie Portfolio Architecture Service or Open Architecture Service; certain institutional investors; and certain qualifying employees of Mackenzie and its subsidiaries.

Series PW and Series PWT5 securities are offered through our Private Wealth Solutions to certain high net worth investors who invest a minimum of \$100,000. Investors in Series PWT5 securities also want to receive a monthly cash flow of 5% per year. Before January 1, 2019, Series PWT5 securities were known as Series PWT6.

Series PWFB securities are offered through our Private Wealth Solutions to certain high net worth investors who invest a minimum of \$100,000. Investors are required to negotiate their advisor service fee, which cannot exceed 1.50%, with their financial advisor.

Series PWR securities are offered through our Private Wealth Solutions to certain high net worth investors who invest a minimum of \$100,000 in a Registered Disability Savings Plan offered by Mackenzie.

Series PWX securities are offered through our Private Wealth Solutions to certain high net worth investors who invest a minimum of \$100,000. Investors are required to negotiate their advisor service fee, which cannot exceed 1.50%, with their financial advisor.

Series E, Series FB5, Series I, Series J, Series PWFB5, Series PWX8 and Series W securities are no longer available for sale.

Series PWF and Series PWF6 securities are no longer available for sale. Effective June 1, 2018, Series PWF and Series PWF6 securities were consolidated into Series F and Series F6 (now Series F5) securities, respectively.

Series LF and Series LF5 securities are offered to retail investors investing a minimum of \$500 (\$5,000 for Series LF5), who are enrolled in the LBC Private Banking sponsored fee-for-service program. Investors in Series LF5 securities also want to receive a monthly cash flow of 5% per year.

Series LW and Series LW5 securities are offered through our Preferred Pricing Program to certain high net worth investors who invest a minimum of \$100,000. Investors in Series LW5 securities also want to receive a monthly cash flow of 5% per year. Before January 1, 2019, Series LW5 securities were known as Series LW6.

Series LM securities are no longer available for sale, except that pre-authorized contribution plans that were in place as at November 25, 2015, may continue.

An investor in the Fund may choose among different purchase options that are available under each series. These purchase options are a sales charge purchase option, a redemption charge purchase option, various low-load purchase options and a no-load purchase option. The charges under the sales charge purchase option are negotiated by investors with their dealers. The charges under the redemption charge and low-load purchase options are paid to Mackenzie if an investor redeems securities of the Fund during specific periods. Not all purchase options are available under each series of the Fund, and the charges for each purchase option may vary among the different series.
